Senators Delores Kelley, Karen Montgomery, Brian Frosh, Paul Pinsky, Jamie Raskin and James Rosapepe should be applauded for putting together such a comprehensive package that not only proposes necessary changes to increase revenue, but offers a much better solution to the 'cuts only' approach to our serious budget problems.
